Marriage is a covenant between a man, a woman, and God and should not be taken casually. At Harvest, we desire that couples enter marriage with God’s blessing, the blessing of Harvest, and a solid understanding of how to have a successful marriage. This is accomplished through successfully completing pre-marital coaching prior to any Harvest officiated ceremony.

Premarital Coaching Process:

- 1. First, purchase the CD series “Before You Say I Do” by our Bishop and each adult should listen to them and then complete the attached questionnaire. Once completed, you will have one coaching session. Additional sessions may be needed. You cannot schedule your session until you have completed listening to the CD series and submitted the attached questionnaires.
2. Then, each party should obtain an individual tri-merge credit report as well as STD testing. Harvest personnel will not review these, but you will need these to complete the attached questionnaires.
3. We strongly advise you NOT to set a date for a wedding ceremony until premarital coaching has been successfully completed. Setting a date prior to that is counter-productive to effective premarital coaching & will in no way expedite Harvest’s process to ensure your success.
4. The coaching session will be scheduled with your campus Administrative Office once this form and the questionnaires has been received.
5. Harvest only officiates ceremonies for couples that have completed Kingdom Life University (KLU). If you have not taken KLU, please attend the next session at your campus or online and you can submit this form & questionnaires after KLU has been completed.
